CITY OF PORTAGEVILLE Public Hearing - Building Commission Portageville City Hall October 15, 2024

APPROVAL OF **AGENDA** 

**OLD BUSINESS** 

Jonathan Thacker, Code Enforcement Officer, approached the Building Commission regarding Portageville Municipal Code violations at property owned by Elco Bruce Young located at 418 W 8th Street. This was the third visit for the property and an update was to be given in order to remove the property from future meetings. Young previously stated that the structure in the rear of property was scheduled to be removed in mid-October; however, there had been no change to the property. Discussion followed. The issue was tabled until November 2024 to see if the structure was removed.

Thacker explained that there had been no change since the previous public hearing and summons had been sent weekly to appear at Portageville Municipal Court. Lane was present and spoke with the Building Commission. Discussion followed. Alderman Cook made a motion to allow 30 days for the removal of the porch and suspend the municipal fines until an update on the progress is given at the December Building Commission Public Hearing. Alderman Faulk seconded. All members voted in favor.

**NEW BUSINESS** 

## 902 FOSTER AVE.

Jonathan Thacker, Code Enforcement Officer, approached the Building Commission regarding Portageville Municipal Code violations at property owned by Anthony Brown located at 902 Foster Ave. This was the first visit for the property. Thacker explained that the structure has dilapidated areas that need to be removed or repaired. Discussion followed. Aiderman Cook made a motion to allow 30 days for the property to be repaired or removed. Alderman Adams seconded. All members voted in favor.
