**OLD BUSINESS** 

PLANNING AND ZONING ALLEY ABANDONMENT

Mayor Berry asked Patty Johnson, Planning and Zoning Chairman, about the public hearing for the proposed alley abandonment. Johnson stated that the public hearing was held on Monday, May 18, 2020 at 5:30 p.m. and there were no public comments regarding the abandonment of the alley located adjacent to Lot 20, Block A of Fairview Addition to Portageville. ## SUMMER HELP POSITIONS

Mayor Berry presented a list of applicants that had applied for summer help positions. There are six positions to be filled around the City of Portageville. Discussion followed. The following list was proposed: Kelsey Kellams, Police; Alex Riddle and Jayse Scherer, Street; Zackary Douglas, Water; Adam Brands, Sewer; Zane Crane, Fire. Mayor Berry asked for a motion to approve the proposed list for summer help positions. Motion was made by Alderman Doering and seconded by Alderman James. All members voted in favor.

Summer positions will start on June 1, 2020. Mayor Berry asked that an email be sent to all applicants not chosen thanking them for their interest in the position.

#### STREET PAVING 2020

Mayor Berry asked if the Alderman had any recommendations for this year's street paving. Discussion followed. All members agreed that Huffman Ave between Main Street and West 12<sup>th</sup> Street should be resurfaced. A motion was made by Alderman James to place an advertisement for bids for the above-mentioned paving. Alderman Johnston seconded. All members voted in favor.

Sealed bids will be opened at the July 6, 2020 Board Meeting. Mayor Berry also mentioned that the sewer department needs to order risers before paving begins, and the street department needs to look at replacing or repairing the drain box on the corner of Huffman Avenue and East 7<sup>th</sup> Street.

Mayor Berry informed the Board of Aldermen that a meeting with Mike Allred, Superintendent for Portageville School District, was scheduled for Thursday to review the current Memorandum of Understanding for the School Resource Officer. Mackie Springer addressed the Board of Alderman concerning why he felt the regulations were not necessary. Springer also informed the Board of
